## Methods and material for containment and cleaning up

Clean area with large quantity of water to complete clean- up.

Wear appropriate personnel protective equipment and clothing to prevent exposure. Avoid breathing in mists or vapours and skin or eyes contact. Prevent, by any means available, spillage from entering drains or water course. Stop leak if safe to do so.
