4. First aid measures

5. Fire measures

The product is not inflammable. In case of fire can generate carbonic oxide and organic substances with low molecular weight, due to resins present in the product.

Extinguish media to use: in case of fire, water-cool the containers and extinguish the fire with normal extinguishing media, none excepted.

Possible exposure risks: CO formation and organic substances in decomposition.

Staff equipment: the staff assigned to extinction the fire must have protective clothes and breathing apparatus in closed areas.

6. Accidental release measures
